Split Payment Option: A Split Payment Option is available for Golf Memberships at the clubs. Initial Payment equal to ½ the annual classification is due upon application. The remaining payment is due on or before 31 Mar 21. The clubs will add a **Split Payment Convenience Fee** of \$25.00 to the amount due at final payment.

Membership Period: Memberships at both Clubs is an Annual Membership **beginning on 1 Jan 2022 and concluding on 31 Dec 2022**. Prorations of Golf, Family Add-On, Junior, and Range Only Membership shall be based on a seven (7) month golf season defined as 1 April through 31 October.

Privileges for Golf Members: A golf membership allows the member to use the golf and clubhouse facilities provided at both clubs and to attend Club Sponsored events held at both, upon payment of the applicable fees, dues, and other charges established by the Club. Golf members shall not be charged green or cart fees for use of the golf facilities but shall pay for the use of additional amenities and charges established by the club. Golf members will enjoy an advance reservation privilege for golf starting times established by the club. Additional amenities available include Annual Lockers, Practice Range, Private and Group Golf Lessons, Junior Golf Camps, Member-only Golf and Social events, Discounts on Golf Shop items.

- Full and Limited Memberships will be provided a GHIN by the USGA for Handicap Services from application until 31 Dec 2022
- Full and Limited Memberships will have access to a Member’s Only Tee Sheet Portal for advanced reservations
- The first 20 Full CTGC Memberships will receive free use of a Locker for male applicants
- All Memberships purchased by 31 Jan 2022 will receive (4) Guest Passes as Member Appreciation Rounds, good for the time periods equivalent to the Membership Classification
- All Memberships include Mill River Pricing in the Golf Shop

Privileges for Social Members (CTGC Only): A Social Membership allows the member to use the dining facilities provided at their Home Club and to attend club sponsored social events, upon payment of the applicable membership fee, dues, fees, and other charges established by the club. Social members may also reserve Golf Tee Times in advance of the general public. Social Members shall pay the applicable required green fees for use of the golf course except as noted below. Social members at CTGC can upgrade to a Golf Membership. The opportunity to upgrade is subject to the availability of such golf memberships and payment to the club of the difference between the membership fee charged by the club for the golf membership at the time. Social Members will enjoy:

- Ten (10) Range Pail vouchers
- Five (5) 18 Hole Rounds of Golf Mon - Friday, anytime; Rack rates apply after (5) Rounds are used
- Mill River Pricing in the Golf Shop
- Preferential Seating and Reservations for Club Sponsored Restaurant Events

Food and Beverage Minimum Spending: As of 21 Dec 2021, there will be no required Food and Beverage Minimum spending for Calendar year 2022 associated with Memberships. All Members are highly encouraged to use their Member Number for all purchases both in the Golf Shop, Restaurant, and Trail Pub.
